US Mayors Climate Protection Agreement Resolution

Trustee Dengler offered the following resolution, and asked for Mayor Seskin to appoint a Task Force to further review the Climate Protection Agreement, which was seconded by Trustee Broda:

US MAYORS CLIMATE PROTECTION AGREEMENT

Whereas, the likely disruption of our climate is a threat to the environmental and economic health of our Village of Dobbs Ferry; and

Whereas, many municipalities, in this country and abroad, already have strong local policies and programs in place to reduce global warming pollution, based on the outlines set forth in the US Mayors Climate Protection Agreement; and

Whereas, it is in the best interests of the Village of Dobbs Ferry to study the advisability of signing on to the US Mayors Climate Protection Agreement in the immediate future;

Now be it resolved, that the Mayor of Dobbs Ferry appoint a citizens task force to examine and advise the Mayor and the Board of Trustees of the benefits of subscribing to the US Mayors Climate Protection Agreement and advising on measures to be taken, and specifically what policies and programs, to implement the participation of the Village in said agreement.
