## RESOLUTION 19-2013

## RESOLUTION AUTHORIZING THE ACCEPANCE OF THE SAFE ROUTES TO SCHOOL GRANT PIN 8761.16

Authorizing the implementation, and funding in the first instance 100% of the federal-aid eligible costs, of a transportation federal-aid project, and appropriating funds therefore.

WHEREAS, a Project for the Village of Dobbs Ferry Safe Routes To School Conceptual Plan, PIN 8761.16 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

**WHEREAS**, the Village of Dobbs Ferry desires to advance the Project by making a commitment of 100% of the non-federal share of the costs.

NOW, THEREFORE, the Dobbs Ferry Village Board, duly convened does hereby

**RESOLVE**, that the Dobbs Ferry Village Board hereby approves the above-subject project; and it is hereby further

**RESOLVED,** that the Dobbs Ferry Village Board hereby authorizes the Village of Dobbs Ferry to pay in the first instance 100% of the federal and non-federal share of the cost of work for the Project or portions thereof; and it is further

**RESOLVED**, that the sum of \$63,500 is hereby appropriated from appropriated fund balance and made available to cover the cost of participation in the above Project; and it is further

**RESOLVED**, that the interium Treasurer is authorized to make the nessarily budget amendment to complete the project; and it is further

**RESOLVED**, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Dobbs Ferry Village Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Mayor thereof; and it is further

**RESOLVED**, that the Mayor of the Village of Dobbs Ferry be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or applicable Marchiselli Aid on behalf of the Village of Dobbs Ferry with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent

funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

**RESOLVED,** that in addition to the Mayor the following municipal titles: Village Administrator, Treasurer are also hereby authorized to execute any necessary Agreements, certifications reimbursement requests on behalf of the Municipality/Sponsor, with NYSDOT in connection with the advancement or approval of the project identified in the State/Local Agreement; and it is further

**RESOLVED,** that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

**RESOLVED**, this Resolution shall take effect immediately.
