**Creation of the ad-hoc Dobbs Ferry Advisory Tourism Board, appointments and BOT Liaison**

Mayor Connett said at the last Board meeting the Board passed a resolution supporting a tourism initiative and the creation of a Tourism Board which will be an effort between the Villages of Dobbs Ferry, Irvington and Hastings, along with the help and assistance of Selling Communications Inc. Mayor Connett said this will be a great way to promote the downtown and increase tourism activity in the Village. Mayor Connett said the Dobbs Ferry Advisory Tourism Board will be comprised of local volunteers who will meet and speak with the Tourism Boards from Hastings and Irvington. Mayor Connett encouraged volunteers to participate in this effort.

Motion by Trustee Golio, seconded by Trustee Koenigsberg to create the ad-hoc Dobbs Ferry Advisory Tourism Board, in conjunction with previous action taken by the Board of Trustees for Dobbs Ferry to actively support a tourism initiative along with the Villages of Irvington and Hastings on Hudson, with the business proposal from Selling Communications Inc., to appoint Deputy Mayor Kay as the Trustee Liaison and Ms. Nina Orville as a regular member of the Board, and that the Mayor will take suggestions from all members of the Board of Trustees and/or members of the community that also have a specific interest to get involved and to work on this Board.
