

**RESOLUTION**

**RE: (AWARD OF CONTRACT FOR THE INSTALLATION OF LED TRAFFIC SIGNAL  
FIXTURES TOWNWIDE)**

**WHEREAS**, The Town of Cortlandt has previously received a grant for this project from NYS Multimodal program, and

**WHEREAS**, The Town Board is desirous of reducing its carbon footprint through reduced energy consumption

**WHEREAS**, The replacement of incandescent light fixtures in traffic signals with LED fixtures is the current standard industry practice as a cost effective means to reduce energy consumption and improve traffic safety; and

**WHEREAS**, Materials necessary for the installation have previously been purchased by the Department of Environmental Services; and

**WHEREAS**, The Purchasing Director has solicited bids for the installation of LED Traffic Signal fixtures and the results are as follows

**WHEREAS**, The Director of the Department of Environmental Services has reviewed the proposals, and recommends awarding the contract to Morabito Electric, and

**WHEREAS**, The Director of the Department of Environmental Services recommends that an allowance for 2 crew days be reserved for any necessary additional work encountered during the installation project at the hourly/daily rate quoted in the proposal; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of Cortlandt authorizes the award of a contract for the installation of LED traffic signal fixtures to Morabito Electric in an amount not to exceed \$8,200 and the 2011 Town budget amended accordingly.
