This Second Amendment is meant to be attached to and amend the terms of an April 3, 2015 agreement and all subsequent Amendments, between the parties hereto and amends the following terms and conditions of said agreement.


- (1) Modify paragraph four, page 1 from *"NOW, THEREFORE, in consideration of an annual fee of \$2,000.00 to be paid by the Market to the Village prior to commencement of operations each year, it is agreed as follows:"* to *"NOW, THEREFORE, in consideration of an annual fee of \$1.00 to be paid by the Market to the Village prior to commencement of operations each year, it is agreed as follows:"*
- (2) Modify first sentence of Item 3 appearing on page 1 from *"The term of this agreement for operation of the "farmers market" shall be five (5) years, namely, the years 2015 through 2019"* to *"The term of this agreement for operation of the "farmers market" shall be three (3) years, namely, the years 2020 through 2022"*.
- (3) Modify second sentence of Item 3 appearing on page 1 from *"Weather and other circumstances permitting, the annual public operation of said "farmer's market" shall commence in May on Mother's Day weekend and end in November on the weekend prior to Thanksgiving in each year"* to *"Weather and other circumstances permitting, the annual public operation of said "farmer's market" shall commence in May on the weekend before Mother's Day weekend and end in December on the last weekend of each year"*.
- (4) Modify third sentence of Item 3 appearing on page 1 from *"The actual selling of produce, products, wares and merchandise shall be restricted to Sunday between the hours of 10:00 a.m. to 2:00 p.m. with reasonable access to the premises before and after those hours for preparation and clean-up by the Market and vendors"* to *"The actual selling of produce, products, wares and merchandise, as well as the provisioning of musicians - who shall comply with applicable segment(s) of Section 89-4.G-8 of the Village Code - shall be restricted to Sunday between the hours of 10:00 a.m. to 2:00 p.m. with reasonable access to the premises before and after those hours for preparation and clean-up by the Market and vendors"*.

Except as herein modified, the provisions of the said April 3, 2015 Agreement and as amended by the First Amendment to the Agreement dated July 12, 2018 shall remain unchanged and unimpaired.
