**AUTHORIZE FORMAL REQUEST TO NATIONAL GRID
FOR THE CONVERSION OF STREETLIGHTS IN THE TOWN OF
CAZENOVIA TO LED TECHNOLOGY AND APPROVE PAYMENT
TO NATIONAL GRID FOR THE CONVERSION**

WHEREAS, the Central New York Regional Planning and Development Board (CNY RPDB) has assisted the Town of Cazenovia with an analysis for converting streetlights in the Town of Cazenovia to Light Emitting Diode (LED) through an initiative known as the "CNY Bright Lights program," which is funded by NYSERDA's Clean Energy Communities program; and

WHEREAS, the Town Board was given an analysis report titled "*LED Streetlight Cost-Benefit Analysis Report for the Town of Cazenovia - October 5, 2016;*" and

WHEREAS, after review of the analysis report presented to them by CNY RPDB determined it would be beneficial to convert all thirty-seven high-pressure sodium (HPS) luminaries along various roadways in the Town of Cazenovia to LED technology; and

WHEREAS, it is projected the payback will be over a span of approximately 10 years if the HPS luminaries are converted to LED bulbs through National Grid's utility-owned LED streetlight tariff; and

WHEREAS, said action is a Type 2 for purposes of the State Environmental Review Act; and

NOW THEREFORE, BE IT RESOLVED, that the Town Board authorizes the Supervisor to make a formal request to National Grid for the conversion of the National Grid-owned cobra head style streetlights in the Town to LED; and it is further

RESOLVED, the Town Board approves payment to National Grid in an amount not to exceed Ten Thousand Dollars and 00/100 (\$ 10,000.00) for this project.
