**RESOLUTION #2102019
 ADOPT 2019 TOWN OF DOVER NATURAL RESOURCE INVENTORY**

The following Resolution was offered by Councilman Abrams, seconded by Councilman Yeno, to wit:

WHEREAS, the Town of Dover adopted the NYS Climate Smart Communities Pledge in July 2016 and established the Climate Smart Dover Task Force to identify and implement a series of action items to achieve Bronze-level certification; and

WHEREAS, the Town of Dover received a Climate Smart Communities certification program grant from the NYS DEC Office of Climate Change to support certification efforts that included the completion of a town-wide natural resource inventory; and

WHEREAS, the Climate Smart Dover Task Force, the Town of Dover Town Board and Hudsonia, Ltd. collaborated in the development of this natural resource inventory with iterations of the draft document circulated for comments and feedback.

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Dover hereby adopts the 2019 Town of Dover Natural Resource Inventory and authorizes its submission to the NYS Office of Climate Change's Climate Smart Communities Program for consideration of action items points toward consideration of Climate Smart Communities Bronze-level certification.

The question of the adoption of the foregoing Resolution was duly put to a vote which resulted as follows:


