### PERMIT INFORMATION

Residential customers can apply for a <u>free</u> permit sticker to save time weighing in and out. Applications can be obtained by calling 763-4450 or online at gobroomecounty.com.

Commercial customers must obtain a permit issued by the landfill. Permits are for one year (July 1-June 30) and are prorated on a per month basis for the remainder of the year. The application fee is \$55, plus \$30 per vehicle. For more information or to receive application forms call 763-4450.

### GIVE BACK PROGRAM

Broome County has a give back program at the Broome County Landfill. Materials such as compost and wood pallets are available at no cost to residents while supplies last.

### RECYCLABLES

There is no charge for dropping off residential recyclables at the landfill. Recyclables must be separated from other wastes and be free of food waste or other contaminants.

### **How to Safely Dispose of Household Sharps**

### Safe Disposal

- Safe disposal of sharps (needles, syringes, lancets) prevents sharps from being re-used or shared, which can spread disease.
- Safe disposal protects children, pets and workers, who handle trash & recyclables. from injury or illness.
- Safe disposal protects the environment.

### **Storing Used Sharps**

Follow guidelines below when storing sharps until they can safely be disposed of.

### DO:

- Place used sharps in a sharps container. Containers can be purchased at local drug stores. If you do not have a sharps container, use a plastic bottle that cannot be broken or punctured, such as a detergent bottle. Screw cap on and tape cap. Write "sharps" on the container. Bring to a designated drop-off location.
- Place sharps in container directly after use. Keep container closed and away from children and pets. Store in a secure location.
- When traveling, bring container with you.

### DON'T:

• Don't put sharp containers in the trash.\*

- **Don't** clip, bend or put the cap back on used sharps.
- Don't put sharps or sharp containers in with the recyclables.
- **Don't** put used sharps in soda cans, milk cartons, glass bottles or containers that can be broken or punctured. Coffee cans are not safe because plastic lids come off easily, or leak, or can be punctured.

Unwanted medications should NOT be flushed down the toilet. If you are not able to bring medications to a drop-off, follow the guidelines below:

- Treat medications (liquids and pills) by adding water and then ashes, dirt, cat litter, coffee grounds, or another undesirable substance. avoid accidental or intentional misuse of drugs.
- Hide all medications in an outer container to prevent discovery and removal from the trash.
- Dispose of drugs as close to your trash collection day as possible.

<sup>\*</sup>Used sharps containers can be placed in the trash only if access to a drop-off is not available.

### **CFL Facts**

Install CFBs in hard-toreach areas, such as hallways, closets, vaulted ceilings, etc. You won't have to climb a ladder again for years to come!



Most CFBs are rated for outdoor use, but read the package carefully to make sure.

CFBs can be used with timers, motion detec-

tors, photocells and occupancy sensors. If you need to use a dimmer switch, look for a CFB designed specifically for dimming.

You can use CFBs to replace bulbs in many halogen lamps, which will save energy and greatly reduce the risk of fire.

### **Compact Fluorescent Bulbs**

Compact fluorescent light (CFL) bulbs when compared to standard incandescent bulbs use 2/3 less energy and last up to 10 times longer. Replacing a 60 watt incandescent bulb with a 13 watt CFL can save at least \$30 in energy cost over the life of the bulb.

### Do CFLs contain mercury?

Yes, CFLs contain a small amount of mercury that is sealed within the glass tubing; an average of 4 milligrams (equivalent to the tip of a ball point pen). Mercury is an irreplaceable element in CFLs and is what allows it to be an efficient

As a comparison an old thermostat could contain up to 3000 milligrams of mercury and a old thermometer could have up to 500 milligrams.

light source.

### Should I be concerned about using CFLs in my home?

CFLs are safe to use. Mercury is not released when bulbs are in use. CFLs are made of glass tubing that may break if dropped or mishandled. Caution should be exercised when removing the lamp from its packaging, installing it or replacing it. Remember, the next time you replace a bulb, to

put a drop cloth on the floor so that any accidental breakage can be easily cleaned up.



CFLs should be disposed of properly. Broome County has a year-round hazardous waste collection facility at the Broome County Landfill. There is no fee for household users. Businesses must make an appointment to bring waste to the facility. Collections are generally held three days a month from 7:30 am to 11:30 am. For a listing of collection days please visit www.gobroomecounty.com or call 778-2250. The facility is open to Broome County residents year-round and Tioga residents from April-November.

### What should I do if a CFL breaks?

Since there is a small amount of mercury in CFLs there are limited health risks. Below are some disposal guidelines to minimize risks.

<u>Do not vacuum!</u> Remember to never use a vacuum. A standard vacuum will spread mercury containing dust

throughout the area as well as contaminating the vacuum. What you should do is: • Ventilate the area. • If possible, reduce the temperature. • Wear appropriate personal protective equipment, such as gloves, safety glasses, coveralls or old clothing, and a dust mask to keep bulb dust and glass from being inhaled. • Carefully remove the larger pieces and place them in a secure closed container. • Next, begin collecting the smaller pieces and dust. There are several ways to do this. You can use two stiff pieces of paper. • Put all material into an airtight plastic bag. Pat the area with the sticky side of duct, packing or masking tape. Wipe the area with a damp cloth. • Put all waste and materials used to clean up the bulb in a secure closed container. • Take the container to the Household Hazardous Waste Facility.

### PAINT TIPS & DISPOSAL

### **Broome County Division of Solid Waste Management**

### **Buy The Right Size**

Find out how to buy the correct amount of paint for your project; thus minimizing the amount of leftover paint for storage, recycling or disposal.

### **Store It Properly**

- Cover the opening of the paint can with plastic wrap before closing the lid.
   Use a mallet instead of a hammer to close the paint can, creating a good seal.
- Store the paint can upside down to create a tight seal around the lid.
- Store paint away from extreme heat and cold.
- Write on the lid of each paint can the date opened, the color, brand and the room it is for.

### **Use It All Up**

Use up all your leftover paint to minimize the amount of paint needing to be stored, reused, recycled or disposed of locally.

### **Donate It**

Contact Habitat for Humanity and other service groups for possible donation.

### **Disposal of Paint**

**Oil-based paint is a combustible material.** It must be disposed of at the Broome County Household Hazardous Waste Facility. Call 778-2250 for more information.

### How to properly dispose of latex paint:

- 1. Remove and **discard** the paint can lid.
- 2. Make sure the paint can is ½ full or less.

  (if the can is more than ½ full, pour excess into another container, like a milk jug or coffee can)
- 3. Add clay-based kitty litter or absorbent material so the can is ¾ full.
- 4. Stir paint/kitty litter mixture. If liquid paint remains, add more kitty litter.
- **5.** Allow paint/kitty litter mixture to air dry until hard (should take approximately 1-2 days).
- **6.** Dispose of can in garbage.

**NOTE:** Do not put the lid back on the paint can! Cans will not be picked up by your hauler it they can't see that the paint is dry.



### Grasscycling Myth

Grass clippings left on the lawn don't cause thatch! Thatch is caused by roots, dead leaf sheaths and rhizomes that decompose slowly. Grass clippings decompose quickly and help make your lawn more vigorous and durable.

## Grasscycling Guidelines Mowing

- ✓ Reverse the mowing direction every other time.
- ✓ Mow when the lawn is dry.
- ✓ A basic rule of thumb is to remove 1/3 of the new growth at a time.
- Mow with a sharp blade to prevent a ragged appearance.
