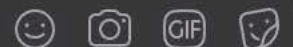

A public hearing will be held by the Town Board of Newfield on Thursday, July 22nd, 2021 at 7:00 p.m. at the Newfield Town Hall, 166 Main Street, Newfield, New York, to obtain public comment and opinion concerning the proposed adoption of a local law amending Local Law No. 1 of 2006, "Providing for the Administration and Enforcement of the New York State Uniform Fire Prevention and Building Code" to add provisions for a local energy code for the Town of Newfield, New York. Written comments may also be submitted to the Town of Newfield Town Clerk at 166 Main Street, Newfield, NY 14867 before noon, July 22nd, 2021. Copies of this proposed local law are on file in the Town Clerk's Office for public inspection during regular business hours.

From the NYS Southern Tier Clean Energy Newsletter Community Spotlight - Town of Newfield

"This quarter, our community spotlight goes to the Town of Newfield! The Town of Newfield has worked hard, and continues to do so, to complete multiple actions in both the Clean Energy Communities (CEC) and Climate Smart Communities (CSC) programs.

Newfield is a designated Clean Energy Community and has completed Benchmarking - Municipal buildings, Energy Code Enforcement Training, Solarize, and Unified Solar Permit. Recently, they adopted the NY Stretch Code and are in the final stages of completing a Clean Heating and Cooling Community Campaign. Once submitted, these last two actions, NY Stretch and Community Campaigns, will make Newfield eligible for two \$5,000 action grants.

Newfield is also a registered Climate Smart Community and is working towards becoming Bronze Certified. So far, they have updated their comprehensive plan to include sustainability elements, performed a fleet inventory, and finished multiple CSC actions."
