I HEREBY CERTIFY, *That at the 6th Session of the Legislature of Erie County, held in the Legislative Chambers, in the City of Buffalo, on the 17th day of March, 2022 A.D., a Resolution was adopted, of which the following is a true copy:*

WHEREAS, Erie County, with the assistance from Tetra Tech, has gathered information and prepared the Erie County Multi-Jurisdictional Hazard Mitigation Plan; and

WHEREAS, the Erie County Multi-Jurisdictional Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, Erie County is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

WHEREAS, Erie County have reviewed the Plan and affirms that the Plan will be updated no less than every five years.

NOW, THEREFORE, BE IT

RESOLVED, the County Executive, on behalf of the Department of Homeland Security & Emergency Services, is authorized to receive this revision of Comm. 3E-19 dated February 1, 2007 and Comm. 12E-18 (2015) date June 25, 2015 from this Honorable Body, which hereby indicate the adoption, updated and acceptance of the Erie County Multi-Jurisdictional Hazard Mitigation Plan, and to forward this resolution, along with the other 44 Municipality resolutions to the Federal Emergency Management Agency (FEMA) so the Plan can be completely approved; and be it further

RESOLVED, Erie County adopts the Multi-Jurisdictional Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the actions in the Plan; and be it further

RESOLVED, that the Erie County Multi-Jurisdictional Hazard Mitigation Plan will be reviewed and amended, as needed, with in a period of every five (5) years; and be it further

RESOLVED, that the Multi-Jurisdictional Hazard Mitigation Plan will allow Erie County and its 44 Municipalities to receive funding from FEMA, as a result of a federally declared disaster, and/or for mitigation aid; and be it further

RESOLVED, that certified copies of this resolution be sent to the County Executive's Office, the Division of Budget and Management, the Department of Personnel, the Department of Homeland Security & Emergency Services c/o Lauren Panaro, the County Comptroller, and the County Attorney.
